# PLI SCHEME

Keeping in view India's vision of becoming '**Atmanirbhar**' and to enhance India's Manufacturing capabilities and Exports, an outlay of **INR 1.97 lakh crore** (US\$ 26 billion) has been announced in **Union Budget 2021-22** for PLI schemes for **13 key sectors** of manufacturing starting from fiscal year (FY) **2021-22**.

The **13 key sectors** include already **existing 3 sectors** namely (i) Mobile Manufacturing and Specified Electronic Components, (ii) Critical Key Starting materials/Drug Intermediaries & Active Pharmaceutical Ingredients, (iii) Manufacturing of Medical Devices and **10 new key sectors** which have been approved by the Union Cabinet in November 2020. These **10 key sectors** are:

(i) Automobiles and Auto Components, (ii) Pharmaceuticals Drugs, (iii) Specialty Steel, (iv) Telecom & Networking Products, (v) Electronic/Technology Products, (vi) White Goods (ACs and LEDs), (vii) Food Products, (viii) Textile Products: MMF segment and technical textiles, (ix) High efficiency solar PV modules, and (x) Advanced Chemistry Cell (ACC) Battery.

PLI Scheme for an **additional sector**, Drones and Drone Components, has also been approved by the Union Cabinet in September 2021. With the announcement of PLI Schemes, significant creation of **production, employment, and economic growth** is expected over the next 5 years and more.

The PLI schemes are being implemented by the concerned Ministries/ Departments. A statement on details received from concerned Ministries/Departments regarding investment made by various sectors after 1<sup>st</sup> April, 2021, to avail Production Linked Incentive (PLI) scheme is placed in the table below:

## Safe Trade Policy

Countries including India, party to the **World Trade Organization (WTO)** are obliged to follow the rules and regulations of international trade under WTO Agreements, including the Most-Favoured Nation (MFN)

clause. WTO also provides scope to derogate under specific conditions including National Security provisions. Accordingly, the Export policy of Govt. of India is framed within such parameters.

For exports from 01.01.2021, a new Scheme named Remission of Duties and Taxes on Exported Products (RoDTEP) has been implemented. The Scheme creates a mechanism for re-imbursalment of taxes/ duties/ levies, which are currently not being refunded under any other mechanism, at the central, state and local level,

but which are incurred in the process of manufacture and distribution of exported products. All exporters, including MSME exporters are eligible to make a claim under **RoDTEP** as per the notified Schedule on eligible export items.

The Ministry of Micro, Small and Medium Enterprises (MSMEs) is implementing various schemes for promotion and development of MSME sector in the country. These include International Cooperation Scheme

**(IC), Prime Minister's Employment Generation Programme (PMEGP), Micro and Small Enterprises-Cluster**

Development Programme (MSE-CDP), Scheme of Fund for Regeneration of Traditional Industries (SFURTI),

Credit Guarantee Fund Trust for Micro and Small Enterprises (CGTMSE), A Scheme for Promoting Innovation, Rural Industry & Entrepreneurship (ASPIRE), Procurement and Market Support Scheme (PMS)

etc.

**Government has taken a number of initiatives under Aatma Nirbhar Bharat Abhiyan to support the MSME**

**Sector in the country especially in Covid-19 Pandemic. Some of them are:**

- i. Rs **20,000** crore Subordinate Debt for MSMEs.
- ii. Rs 3 lakh crores Collateral free Automatic Loans for business, including MSMEs (existing overall guarantee limit under ECGLS has been enhanced from Rs. 3 lakh crore to Rs. **4.5 lakh crore**).
- iii. Rs. 50,000 crore equity infusion through MSME Fund of Funds.
- iv. New revised criteria for classification of MSMEs.
- v. New Registration of MSMEs through 'Udyam Registration' for Ease of Doing Business.
- vi. No global tenders for procurement up to Rs. 200 crores, this will help MSME.

The Ministry of MSME has also opened 52 Export Facilitation Centres (EFC) in different parts of the country to provide assistance to MSME exporters.

This information was given by Union Minister for MSME Shri Narayan Rane in a written reply in Rajya Sabha today.
